REGULAR MEETING

In the absence of President Heavner, a motion to appoint Kyle Duffy as acting president was made by Valentine, second by Nowlan, all aye, motion carried.

Roll Call: Kyle Duffy, Rob Nowlan, Tim Valentine, Adam Tyberendt were all present with Howard Heavner, Kaylee Dependahl and Butch Ford absent. Also in attendance were Larry Andres, Tim Richards and Terry Marquardt. There being a quorum present the meeting was called to order at 7:30 p.m. by acting President, Duffy, at the Village Hall.

The minutes from the previous meeting were approved with a motion by Nowlan, second by Tyberendt, all aye, Heavner, Dependahl and Ford absent, motion carried.

The monthly expenditures were read. A motion to approve was made by Valentine, second by Nowlan, all aye, Heavner, Dependahl and Ford absent, motion carried.

The Maintenance Report was reviewed. A motion to approve was made by Tyberendt, second by Valentine, all aye, Heavener, Dependahl and Ford absent, motion carried.

The Police Report was reviewed with a motion to approve by Valentine, second by Tyberendt, all aye, Heavner, Dependahl and Ford absent, motion carried.

The Treasurer's Report was read. A motion to approve by Nowlan, second by Tyberendt, all aye, Heavner, Dependahl, and Ford absent, motion carried. Duffy asked if we could get an explanation on how to read the new format of the Treasurer's report at next month's first meeting.

- Emergency Services: Tyberendt informed the Board that Heavner, Knobloch and himself received an email from Kevin Scheibe, with the EMA. A motion to remove Laurie Borwn's name and add Ashley Stuckmeyer's name on the accounts was made by Valentine, second by Nowlan, all aye, Heavner, Dependahl and Ford absent, motion passed.

Richards sent the Finance Committee a comparative spreadsheet with the benefit schedule that he is proposing and what surrounding municipalities offer. With Richards proposal, you receive the same benefits but in a shorter amount of time. A motion to approve the recommended vacation/sick time proposal was made by Valentine, second by Tyberendt, all aye, Heavner, Dependahl and Ford absent, motion passed.

Richards gave the board an update on Rock City, stating that he received a tour of the East Mine last week. They are continuing to do multiple tests while in their testing phase.

A motion to approve Ordinance 25-06-An Ordinance Regulating Development in Floodplain Areas was made by Nowlan, second by Valentine, all aye, Heavner, Dependahl and Ford absent, motion passed.

FFA Alumni reached out asking to hold their annual tractor show and parade, September 21st. A motion to approve the Annual Tractor Show was made by Tyberendt, second by Valentine, all aye, Heavner, Dependahl and Ford absent, motion passed.

There being no further business, a motion to adjourn at 7:57 p.m. was made by Tyberendt, second by Nowlan, all aye, motion carried.
